The applications of those,

- A) Provided that the candidates are in the final year of high school or graduates,
- 1) who are foreign nationality,

- 2) who were Turkish citizens at birth but received permission of expatriation for the Ministry of Internal Affairs and their underage children who are registered these people's expatriation document and have the document of 5203 numbered law; use of rights recognized by the law. (The Article 7 of the law no. 5901 of the Law on Turkish Citizenship "(1) A child born in Turkey or abroad to a mother or father of Turkish nationality in a legal marriage bond is a Turkish citizen." Accordingly, applicants who will apply for admission from abroad are recommended to review the law on Turkish citizenship.)
- 3) who has a birth right foreign citizenship but later acquired Turkish citizenship, and thus dual citizenship,
- 4) a) Among those students of Turkish Republic citizenship who continued their secondary education in foreign countries before 1st of February 2013, the ones who have completed the last three years of secondary education (high school) in a foreign country except for TRNC (Turkish Republic of Northern Cyprus)) (including those who have completed all of their secondary (high school) education in Turkish schools established within the scope of MNE (Turkish Ministry of National Education) in foreign countries other than TRNC),
- b) Among those candidates who have started their secondary education in a foreign country after 1st of February 2013, the ones who have completed all of their secondary (high school) education in a foreign country except TRNC (including those who have completed all of their secondary (high school) education in Turkish schools established within MNE in foreign countries other than TRNC) to the foreign acceptance quotas,
- 5) with TRNC citizenship who reside in TRNC and have completed their secondary education there and have the score of GCE-AL and those who enrolled colleges and high schools in other countries and have the score of GCE-AL or will have the score of GCE-AL,

will be accepted.

B) The applications of those who,

- 1) hold TR citizenship and have completed all of their secondary education in Turkey or TRNC,
- 2) hold TRNC citizenship (except for those who completed all of their secondary education at high schools in TRNC and hold GCE-AL scores and those who enrolled and studied at colleges or high schools in other countries between 2005-2010 and have or will have GCE-AL scores)

- 3) hold dual citizenships whose first nationality is Turkish at birth as defined in the 2nd article of (a) subsection, except for those who provide the requirements defined in the 4th article of (a) subsection),
- 4) hold dual citizenships, one of which is T.R citizenship (except for those who have completed all of their secondary education at high schools in TRNC and hold GCE-AL examination results and those who enrolled at high schools in other countries between 2005-2010, studied there and hold or will hold GCE-AL examination results)
- 5) hold T.R citizenship or dual citizenships whose first citizenship is T.R at birth as defined in the 2nd article of (a) subsection and study at schools operating within the scope of embassies in Turkey and foreign high schools in Turkey,

will not be accepted.

APPLICATION DATES AND PROCEDURES

- Placement applications will be done online at https://obs.sdu.edu.tr/Public/YOSGiris.aspx on the dates between 5th -23rd June 2017. During the application procedure, the candidates are supposed to fill in the "Candidate Application Form" carefully, upload the documents required for application to the system, and take a printout of the application to keep.
- Candidate number (passport no) are required to be kept carefully by the candidate since it will be necessary for all the online processes.
- The identity information field of the candidate application form is required to be filled in according to the information on the identification card issued by the official authorities or the passport without abbreviation and replacement. (All responsibility for the consequences of inaccuracies related to information belongs to the candidates.)
- Candidates are allowed to apply for (5) diploma programmes at most.
- Candidates are required to choose the score type to be used in the placement carefully. (exam score or secondary education grade)
- International Students Application will be done online at Süleyman Demirel University
 official website, and the other required documents will be uploaded to the system online.
 Applications that are not made within the application period and the applications of those
 who have not uploaded the required documents or who have uploaded deficient
 documents will not be accepted.

NOTE: Süleyman Demirel University has not authorized any intermediary centres and / or agencies in the application and placement process. There is **NO CHARGE** for placement application.

- Transcript certified by Turkish Republic foreign representative offices (demanded 0from candidates who wish to be placed with grade point average)
- Certified copy of high school diploma and graduation certificate (If these documents are
 not in Turkish, translation of these documents by Turkish Republic foreign representative
 offices or notary certified translation of these documents.)
- For students to be graduate on the application date, educational background certificate (If
 these documents are not in Turkish, translation of these documents by Turkish Republic
 foreign representatives office or notary certified translation of these documents.)
- Copy of the Passport

ASSESMENT OF APPLICATIONS

Placement;

- a) is done by using the formulas specified in Appendix 3 and according to the examination results of SDUYÖS and the ones specified in Appendix 1.
- b) In the event that there are unoccupied quotas; is done by using the formulas specified in Appendix 3 and according to YÖS results of other universities recognized by SDU and the ones specified in Appendix 2 in compliance with the preferences of the candidate.
- c) In the event that there are still unoccupied quotas; according to GPA, provided that the candidates can certify their secondary education GPA (grade point average).
- ç) The evaluation of the applications of the applicants applying to the programs, which admit students with the Special Talent Exam, are determined according to the special talent exam score and the order or preference.
- d) Examinations that are in the status of high school graduation exams are valid for an indefinite period of time and the examinations in the status of university entrance exams are valid for 2 (two) years. YÖS examinations of Turkish universities, which are recognized by SDU, are valid for 1 (one) year.

ANNOUNCEMENT OF THOSE WHO ARE ENTITLED TO REGISTER

REGISTRATION DATES

• Registration processes of original candidates who are entitled to register will be made between the dates of 17th July-4th July 2017, of unoccupied quotas and of substitute candidates 8th-25th August 2017, and of additional placement candidates on 29th September 2017 by related Faculty/School/Vocational School. For registration, candidates are required to apply to the registration centre in person. Registration via mail will not be accepted. The candidates, who have not register on the specified dates, can not claim any rights.

REQUIRED DOCUMENTS FOR REGISTRATION

Required documents for registration are these;

- 1) a) Along with their acceptance of letter, candidates are required to take an Student Visa from a Turkish Republic foreign representative offices in their country (or the nearest)
 - **b**) The candidates in Turkey are required to take a residence permit from Provincial Directorate of Migration Management instead of a Student Visa
 - c) Student Visa is not demanded from the candidates listed below:
 - 1) Foreign students having completed their secondary education in Turkey and demanding to go on their undergraduate education without a break and the children of foreigners having work and residence permit in Turkey.
 - 2) Those having Turkish nationality at birth, but, then having given up their nationality upon the Council of Ministers' decision and having been admitted to the citizenship of a foreign state; including the holders of document for the Use of the Rights Granted by the Law, No. 5901.
 - 3) Holders of dual citizenship having foreign nationality at birth, but, then having been admitted to citizenship of Turkish Republic and those who have Turkish citizenships and have completed the last three years of high school education in a foreign country except Turkish Republic.
 - 2) The original high school diploma and the original temporary graduation certificate with their translation from a Notary Public or Turkish Republic Foreign Representative Offices.

- 3) The original high school diploma taken from Turkish Ministry of Education Provincial Directorate of National Education or the equivalence certificate taken from Turkish Republic Foreign Representative Offices.
- **4**) The original transcript, showing the candidate's high school subjects, grades and grade point average, approved by high school administration and a certified Turkish translated copy of transcript by Turkish Republic Foreign Representative Offices.
- 5) The candidates are required to submit the originals of required papers. The candidates, placed with YÖS score of Turkish universities recognized by SDU, are required to have verification code on their YÖS score printouts or take "true copy of the original" seal from the institution he/she took the document.
- 6) The pages of the passport with Student Visa showing the identification information and validity period and a certified copy of Turkish translation of these pages from a Notary Public or Turkish Republic Foreign Representative Offices.
- 7) If available, a certified copy of internationally recognized foreign language proficiency certificate and Turkish proficiency certificate from Notary Public or Turkish Republic Foreign Representative Offices.
- **8**) Eight photographs to be 4.5x6 cm. in size (the photographs should be taken in the last 6 months, from front, and enable the candidate to be clearly recognized.)
